Registration of Joint Manager (Agricultural Management Body)

| Ministry of Agriculture, Food and Rural Affairs |



Purpose

- To implement a joint manager system, which guarantees gender equality and occupational status of woman farmers
- * To introduce and operate an agricultural management body system that integrates and manages information of individual agricultural management bodies to promote customized farm administration and enhance the efficiency of policy and financial projects

Method

- Indication of the joint manager (O, X) at the bottom right corner of the registration form when registering or changing the registration of an agricultural management body by a farmer (phone request available)

Registration Targets

- Limited to spouses of managers

Registration Benefits

- Improved occupational status of women and provision of maternity allowance of KRW 1.5 million

Registration Request

- Call Center of National Agricultural Products Quality Management Service, 1644-8778
- * Agricultural Management Body Registration Confirmation can be issued using an automated civil service machine in Eup, Myeon, and Dong Offices.

Increased Ratio of Women in Government Commissions

| Ministry of Agriculture, Food and Rural Affairs |



Purpose

- To continuously inspect and strengthen communication so that government commissions of the Ministry of Agriculture, Food and Rural Affairs maintains the legal ratio of women at 40% or above
- * Ministry of Agriculture, Food and Rural Affairs, 2018, 49.8%

Details

- Guidance of government commissions (24) under the Ministry of Agricultural, Food and Rural Affairs to preferentially appoint women in 2019

Formation of Woman Farmer Policy Panel

| Ministry of Agriculture, Food and Rural Affairs |



Purpose

- To form and operate a policy panel of woman farmers to strengthen on-site and expert communications related to woman farmers

Increased Ratio of Female Members and Executives (Agricultural Cooperatives)

Related Agencies



Purpose

- To instruct cooperatives that have not fulfilled the obligation to appoint female directors to comply with the 「Agricultural Cooperatives Act」 through the National Agricultural Cooperatives Act and to expand competency education for cooperative members

* Article 45, paragraph 8 of the 「Agricultural Cooperatives Act」: Obliges cooperatives comprising over 30% woman farmers to appoint a female director

* Goals for woman farmers and executives in 2020: 35% of members, 10% of executives

Purpose

- To promote consistent and stable policies from the central government to regions by installing an exclusive department in local governments

Details

- (Gangwon) Appointed an officer in charge of woman farmers in Agricultural Human Resource Team (1 person)
* Woman farmer welfare voucher, work environment improvement
- (Jeonnam) Appointed professionals in Woman Farmer Support Team (2 persons)
* Support on small-scale startup of woman farmers and policy education on woman farmers
- (Chungnam) Appointed professionals in Farm Village Welfare Woman Team (2 persons)
- (Naju) Created Woman Farmer Support Team (2 persons)
* Farming technique contest for woman farmers, humanities and philosophy lectures for woman farmers
- (Buyeo) Appointed a person in charge of woman farmers (1 person)
- (Asan) Appointed a person in charge of woman farmers (1 person)



Development and Lease of Woman-Friendly Farming Machines

| Ministry of Agriculture, Food and Rural Affairs |



Purpose of Project

- To reduce labor and improve working conditions of woman farmers by developing high-demand farming machines for woman farmers

Details of Project

- Development of woman-friendly farming machines based on opinions collected at the site
- Collected opinions from woman farmer organizations and designated woman-friendly farming machines to supply them to farming machine lease offices starting in 2016

Types of Farming Machine Lease Business

- ❁ **Short-term lease:** Lease for 1~3 days by local governments (farming machine lease offices) to many farms
- ❁ **Long-term lease:** Lease of farming machines for the service life or longer by local governments (farming machine lease offices) through 'integrated mechanization' project, and agency of farm work by long-term lessees using leased farming machines
- ❁ **Farm work agency:** Farm work requested by another farmer is performed using farming machines leased from local governments (farming machine lease offices)
 - * Farm work agency also available at Farming Machine Bank of National Agricultural Cooperative Federation

Preferential Policy for Woman Farmers

| Ministry of Agriculture, Food and Rural Affairs |



Project to Foster Agricultural Successors

Purpose of Project

- ❁ To establish the foundation and provide financing for farmers and farmers-to-be to foster agricultural successors

Details

- ❁ Financing of a fund to prepare the groundwork for startups in the field of agriculture and livestock, such as the purchase of farmlands and installation of facilities

* Maximum loan of KRW 300 million at an annual interest rate of 2% with a 3-year grace period and 7-year installment

Selection System

- ❁ Request → Document evaluation by the person in charge of the city or district → Verification of evaluation results of the Ministry of Agriculture, Food and Rural Affairs (Korea Agency of Education, Promotion & Information Service in Food, Agriculture, Forestry & Fisheries) → Final selection by the city or province

Preferential Selection

- ❁ Recommendation of 1.5 times the quota by city and district mayors, including over 20% of female and multicultural members
- * Excluded from preferential recommendation if the spouse is the agricultural successor

Farming Convergence Industry Foothold Mentoring Project

Details of Project

- ❁ Selection of 20 small-scale, woman or youth businesses among certified businesses to provide product consulting for distribution channels such as supermarkets and department stores

Selection Criteria

- ❁ Selection of certified businesses through the recommendation of each support center, giving priority to
 - ① Small-scale, woman, and youth businesses
 - ② Small-scale and youth businesses
 - ③ Small-scale and woman businesses
 - ④ Small-scale businesses

- To enhance added values of regional farm products and increase economic capability by supporting startups of farmers using domestic raw materials

- To reduce labor and improve working conditions of woman farmers by introducing convenient farming equipment and methods

- Operation of farm coordinators who visit villages to introduce convenient equipment and methods to switch from scooching to standing work and extract farming skills for villages

- Introduction of sporting goods and exercise therapies to treat musculoskeletal pain caused by intense farm work
- Public relations and counseling in 20 Eup, Myeon, and Dong by two coordinators who completed 15 education sessions

Purpose of Ordinance Enactment

- ❁ To contribute to sustainable farming and healthy food production by preserving and growing local farm products grown or cultivated on our land

Details

- ❁ Provision of direct payment for income preservation, support on exemplary businesses processing and distributing local farm products, and promotion of local farm products to reinvigorate consumption

* Contents of ordinances differ among local governments.

Ordinance Enactment Status

- ❁ Ordinances enacted and operated by 16* local governments as of November 2019

* Gyeonggi, Gangwon, Chungnam, Jeonbuk, Jeonnam, Gyeongbuk, Gyeongnam, Jeju, Gyeongang, Anyang, Hwaseong, Hoengseong, Goesan, Gochang, Suncheon, Yeosu



Childcare Improvement Project

| Ministry of Agriculture, Food and Rural Affairs |



Support on Farming Village Children Care Center

Purpose of Project

- To improve childcare conditions in farming villages by installing and operating small-scale (3~20 persons) daycare centers in Eup and Myeon without public nursery facilities

Details of Support

- Facility expense of KRW 152 million and operating expense of KRW 13.7 million (50% covered by the national government and 50% by the local government)

Targets of Support

- Public daycare centers and social welfare foundation centers that install and operate a farming village children care center

Childcare Center in Farming Season

Farm and Education Helpers

Purpose of Project

- To help stable farming by providing farming helpers to farms troubled by accidents or diseases

Targets of Support

- If a farmer with farmland smaller than 5ha is diagnosed with an injury for two weeks or longer because of an accident or is hospitalized for three days or longer because of an accident or disease
- If a farmer is diagnosed with one of the four major diseases and has received outpatient treatment for the disease in the last six months
- Woman farmers who participated in a farmer education course* for at least one day

* A 6-hour education course or longer supervised by the Ministry of Agriculture, Food and Rural Affairs (including its subordinate agencies), local government, National Agricultural Cooperative Federation, central government ministries, or non-profit organizations approved by the central or local government

Details of Support

- Labor expense of KRW 70,000 per day for farming helpers (within 10 days)

* Out of KRW 70,000 per day, KRW 49,000 covered by the national government (70%) and KRW 21,000 by self (30%)

Application Method

- Submitted to the regional agricultural cooperative by attaching an application form and documentary evidence

Happiness Sharing

Purpose of Project

- To promote stable farming and livelihood by providing housekeepers for vulnerable households

Targets of Support

- Households of persons aged 65 years or above in farming villages (including elders who live alone), recipients (below 50% of median income), multicultural households, grandparent households, disabled households, and senior centers of Eup and Myeon

Details of Support

- KRW 10,500 covered by the national subsidy, 70% of KRW 15,000 per day (30% covered by the National Agricultural Cooperative Federation)

Application Method

- Visiting of the regional agricultural cooperative or phone call

Happiness Bus

Response to domestic violence

- Call the police at 112 without area code.
- Call the hotline for women at 1366 or ask for help at a nearby domestic violence counseling center.
- Immigrant women can call 1577-1366 for counseling in 13 different languages.
- When the police arrive, describe the violence situation accurately and precisely.

Support systems for victims of domestic violence

Counseling support

- The special hotline at “1366” without area code is operated 24/7 so that victims can receive counseling via phone or in person.
※ Immigrant women can receive 24-hour counseling in their native languages:1577-1366

Emergency support

- Emergency support is available to victims of domestic violence and their family members who have difficulty making a living.

Medical support

- Medical treatment, protection, and free examination are provided to victims who need physical and mental treatment because of domestic violence.

Free legal support

- Victims of domestic violence (including immigrant women who live in Korea) can seek free legal counseling and aid for civil cases and domestic cases related to domestic violence.

Shelter support

- Victims of domestic violence can move into a shelter after an interview. In particular, there are protection facilities in operation for victims of domestic violence who have a boy aged 10 years or above.
